 - Open Enrollment active and promising so far; targeting balanced class sizes K 1:26, 1-3 1:29, 4-5 1:31; normally 3+ over in all rounds to add a teacher/round; outlook clearer around spring break
 - PK: 2 full days, +2.5 days tuition based; longer days add compliance/logistics challenges
 - Bright Spot grant discovery phase around spending rules

 - Recent discussions:
 - There was a positive report on progress on the unified improvement plan (UIP). The district is meeting discipline implementation, acceleration, and support benchmarks. For elementary school students, there's a new

- acceleration solution in place, as well as TAG screening in 6th grade. There's also progress on updating instructional models, including new elementary science materials that have been delivered.
- The Board report highlighted that open enrollment closes January 9th and requested that families spread the word.
- There is a draft updated attendance policy (JH and JH-R) that addresses many of the concerns raised in SAC (and that focuses mainly on high school issues). The policy may go before the Board in March.
- DAC reviewed its budget recommendations for 2024–25. DAC appreciated input from all of the SACs. The priorities for focus are continued differentiated funding, socio-emotional supports (e.g., counseling), focusing resources on growth (e.g., low-performing), and funding for all students to excel (e.g., TAG). These recommendations should be finalized shortly.

 - Didn't seem like Board was keen to adding more focus schools as a solution to declining enrollment trends
 - Focus schools were added at a very different time in BVSD
- Notes:
 - SOBO has dual enrollment areas (unique in BVSD), BCE benefits
 - Not yet at moment to make recommendations to Board and take action
 - Several focus schools within 3 mi of BCE, some open enrollment only, 1000 students in Boulder
 - Neighborhood school closing opens space for Charter school
 - Proposal to make all schools Focus/all open met with wariness
 - Trend is higher ratio of open enrollment requests
 - Local funding simplistically relates to property tax base, but at state and federal its based on student; means declining enrollment adds proportional burden on local funding
 - Resident capture % reflects effectiveness of marketing/competitiveness; capture % is comparatively high, may mean enrollment challenges likely need to be solved at district level

Colorado State Statute <u>22-11-402</u> and BVSD policies <u>AE</u> and <u>AE-R</u> established SAC powers and duties. SAC responsibilities include the following:

- Recommending to the principal of the school priorities for spending school moneys, including federal funds, where applicable;
- Making recommendations to the principal of the school and the superintendent concerning preparation of a school Performance or Improvement plan, if either type of plan is required;
- Meeting a least quarterly to discuss whether school leadership, personnel, and infrastructure are advancing or impeding implementation of the public school's Performance, Improvement, Priority Improvement, or Turnaround plan, whichever is applicable, and other progress pertinent to the public school's accreditation contract;

- Providing input and recommendations to the DAC and district administration, on an advisory basis, concerning principal development plans and evaluations;
- Publicizing opportunities to serve and soliciting parents to serve on the SAC
- Assisting the district in implementing at the school level the district's family engagement policy; and
- Assisting school personnel to increase family engagement with teachers, including family engagement in creating READ plans, Individual Career and Academic Plans, and plans to address habitual truancy.

Each school is responsible for establishing a School Accountability Committee (SAC). Colorado State Statute <u>22-11-401</u> and BVSD policy (<u>AE-R</u>) determine membership requirements. Each SAC should consist of at least the following seven members:

- The principal of the school or the principal's designee;
- At least one teacher who provides instruction in the school;
- At least three parents of students enrolled in the school
- At least one adult member of an organization of parents, teachers, and students recognized by the school; and
- At least one person from the community

A person may not be appointed or elected to fill more than one of these required member positions in a single term. The number of parents must exceed the number of representatives from the group with the next highest representation. Finally, SACs must select one of their parent representatives to serve as chair or co-chair of the committee.

Note: To the extent practicable, parents serving on accountability committees should reflect the student populations that are significantly represented within the school. Such student populations may include, but not be limited to, students who are members of non-Caucasian races, those who are eligible for free or reduced-cost lunch, those who are Emerging Bilingual students, migrant children, students who are identified as having a disability and students who are identified as gifted.

Note: Generally, a parent who is an employee of the school or who is a spouse, son, daughter, sister, brother, mother or father of a person who is an employee of the school is not eligible to serve on a SAC. However, if, after making good-faith efforts, a principal or organization of parents, teachers and students is unable to find a sufficient number of persons who are willing to serve on the SAC, the principal, with advice from the organization of parents, teachers and students, may establish an alternative membership plan for the SAC that reflects the membership specified above as much as possible.
